#### **Pioneers in Early Education:**

**W. Steven Barnett, Senior Co-Director, National Institute for Early Education Research**Steve is an economist whose research includes early care education costs and benefits, long-term effects of preschool programs on children's learning and development, and distribution of educational opportunities. His best known works include reviews of the research on long-term effects; benefit-cost analyses of the Perry Preschool and Abecedarian programs; and the series of *State of Preschool* reports providing annual state-by-state analyses of progress in public pre-K.

Barbara Bowman, Co-Founder and Irving B. Harris Professor, Erikson Institute
Barbara is an early childhood education expert/advocate, professor, and author. Her areas of
expertise include early childhood care/education and educational equity for minority and lowincome children. She has served on several boards and was the co-founder of Erikson Institute,
where she pioneered the teaching of early childhood education and administration.

## Sue Bredekamp, Early Childhood Consultant, HighScope Board Emeritus

Sue is an early childhood education specialist from Washington, DC, who serves as a consultant on topics such as early literacy, curriculum, teaching, and professional development. From 1981–1998, she served as Director of Accreditation and Professional Development at the National Association for the Education of Young Children (NAEYC). She is the primary author of NAEYC's Developmentally Appropriate Practice in Early Childhood Programs.

# Linda Espinosa, Professor Emeritus of Early Childhood Education at the University of Missouri, Columbia

Linda has served as the Co-Director of the National Institute for Early Education Research (NIEER) at Rutgers University and Vice President at Bright Horizons Family Solutions. She was most recently Co-PI for the Getting on Track for Early School Success: Effective Teaching in Preschool Classrooms project at the University of Chicago and former Co-PI for the Center for Early Care and Education Research—Dual Language Learners (CECER-DLL) at Frank Porter Graham CDI at the U of NC. Her recent research and policy work has focused on effective curriculum and assessment practices for young children from low-income families who are dual language learners. Linda was a contributing author of the report from NASEM (2017), *Promoting the educational success of children learning English*.

**Eugene García, Professor Emeritus and Research Professor, Arizona State University**Gene is a Professor Emeritus at Arizona State University (ASU) where he served as dean of the Mary Lou Fulton College of Education and vice president for education partnerships at ASU. He has been a recipient of a National Kellogg Leadership Fellowship and received numerous academic and

public honors. Gene served as a senior officer in the U.S. Department of Education (1993-1995). His most recent books include "Young English Language Learners" (2010), edited with E. Frede (Teachers College Press), "Bilingualism and Cognition" (2011) with Jose Nanez (American Psychological Association) and "Understanding the Language Development and Early Education of Hispanic Children" with Erminda Garcia (2012) Teachers College Press.

#### Marilou Hyson, Ph.D. early childhood development consultant

Marilou consults nationally and internationally on early childhood development, including involvement in projects with the World Bank, UNICEF, and Save the Children. Previously Professor and Chair at the University of Delaware, she was also NAEYC's associate executive director for professional development, collaborating on position statements and initiatives on critical early childhood issues. A former SRCD fellow in the US Department of Education, Marilou's research and publications have focused on social and emotional development, approaches to learning, and parents' and teachers' beliefs about early education.

#### Sharon Lynn Kagan, Co-Director of the National Center for Children and Families

Lynn is the Virginia and Leonard Marx Professor of Early Childhood and Family Policy and Co-Director of the National Center for Children and Families at Teachers College, Columbia University, and Professor Adjunct at Yale University's Child Study Center. Recognized internationally and nationally for her accomplishments related to the care and education of young children, Lynn is a prolific pubic speaker, author of 325 articles and 16 books, a member of over 30 national boards or panels. Lynn focuses her scholarship on the development of new knowledge that impacts governments and institutions as they craft policies for young children, according particular attention to systems theory, governance, finance, pedagogy, and transitions.

### Joan Lombardi, Early Opportunities, LLC

Joan currently directs Early Opportunities LLC, a philanthropic advisement service focused on the development of young children, families and the communities that support them. In this role she provides overall advisement to the Buffett Early Childhood Fund and to the Pritzker Children's Initiative. Joan served in the U.S. Department of Health and Human Services as the first Deputy Assistant Secretary for Early Childhood Development (2009-2011) and the first Commissioner of the Child Care Bureau (1993-1998).

# Evelyn Moore, Founder and Executive Director Emeritus, National Black Child Development Institute

Evelyn was a founding teacher in the Perry Preschool Program, nationally and internationally known for her work in early childhood education. Evelyn is the founder and Executive Director Emeritus of the National Black Child Development Institute.

Larry Schweinhart, President Emeritus, HighScope Educational Research Foundation

Larry served as president of the HighScope Educational Research Foundation in Ypsilanti, Michigan, since 2003. He became president emeritus in 2013. He has directed the HighScope Perry Preschool Study through age 40, the Michigan School Readiness Program Evaluation, and HighScope's Head Start Quality Research Center.



#### Valora Washington, CEO, Council for Professional Recognition

Valora is CEO of the Council for Professional Recognition, leads the largest credentialing program (CDA) for early educators in the USA.
